

Resolution of the Presidents Committee
on
inflation adjustments to membership contributions
(Resolution 3/2017)

CONSIDERING that Article 26(d) of the IOSCO By-laws state that Presidents Committee will determine the annual contribution of members.

CONSIDERING that the Presidents Committee Resolution on IOSCO's Strategic Direction from 2016 to 2020 and on Funding the Strategic Direction from 2016 to 2020 determined that the IOSCO membership contributions would be adjusted for inflationary increases to take effect in 2018 based on Spanish inflation in 2015 and 2016.

CONSIDERING that the Spanish National Statistics Institute has determined that the Consumer Price Index in Spain from January 2015 to December 2016 has been by 3.2%.

CONSIDERING that it is desirable to introduce an automatic mechanism to index membership contributions to inflation on a bi-annual basis without prejudice to Article 26.d of the IOSCO By-laws.

IT IS AGREED:

1. That annual membership contributions for all membership categories for 2018 and 2019 will be increased by 3.2%.
2. That the resulting membership contribution structure as of 1 January 2018 will be set according to Table 1 below:

3. That membership contributions for 2020 will be adjusted for publicly available official inflation in Spain in 2017 and 2018. The Secretary General, after consultation with the Finance and Audit Committee, will inform the Presidents Committee about the Spanish official inflation for 2017 and 2018.
